## **MULES NATIONAL GOLF COURSE MEMBERSHIP AGREEMENT**

### **ADDITIONAL TERMS AND CONDITIONS OF MEMBERSHIP**

This agreement for golf playing memberships, when approved, is made subject to the terms and conditions set forth in the membership information publication and the following:

1. All applications for membership shall be approved or rejected by University of Central Missouri and Mules National Golf Course.
2. A membership, when issued, is non-transferable.
3. Membership Includes:
  - a) Golf privileges (does not apply to non-club sponsored tournaments)
  - b) Driving range privileges (for his/her use only)
  - c) 15% discount on all regularly priced merchandise in the Pro Shop
  - d) 5%, 10%, 15% discounts in Traditions Restaurant
  - e) Ten-day advance tee time privileges
4. Playing privileges under all memberships are subject to the rules and regulations as are adopted from time to time by Mules National Golf Course. Membership does not include share interest or ownership of any kind in Mules National Golf Course.
5. Membership fees shall be paid in one of the following manners:
  - a. Membership fees paid in full upon joining. Receive 5% discount.
  - b. You may pay in twelve monthly installments. Your first and last months payments are due upon application approval, and thereafter on the 15<sup>th</sup> of each month.
6. Membership will run one full year from the date your application is approved.
7. University of Central Missouri and Mules National Golf Course reserves the right, at any time, to cancel the membership issued to any applicant upon 15 days written notice.
8. Any applicant who is one-month delinquent in payment of their membership fees forfeits all rights to said membership and any fees paid.
9. Memberships will not be refunded at any time.
